Such information may include, but is not limited to, records of arrests for criminal offenses, the circumstances involved in any such arrests, the suspension or revocation of any license or registration authorizing me to engage in any profession or occupation, or the rejection of my application for any such license or registration, and the reasons for such suspension, revocation, or rejection.
