PLEASE READ THE FOLLOWING INFORMATION CAREFULLY

This list is provided as a service to Salesperson and Broker applicants and licensees. Its purpose is to provide specific provider information and advise the reader of which offerings will meet the Pre-License education requirements of the Nebraska Real Estate License Act. "First Date Offer for Credit" in the last column indicates the first date on which a course can be, or could have been, taken in order to count toward the education requirement. This is not a schedule; activities and courses are scheduled on an on-going basis by the provider and all inquiries regarding scheduling should be referred to the provider. Course scheduling and cancellations of courses are a matter of individual provider policy over which the Real Estate Commission has no control. Providers of education are listed in alphabetical order and contact information may be found for each entity.

For courses to be used for licensing purposes, students must complete 100% of the course or activity; the course must have been taken while the course was recognized by the Real Estate Commission and for the total number of hours certified. **All Salesperson and Broker Pre-License courses may be used to meet the Salesperson and Broker Continuing Education requirements except for Real Estate Principles & Practices or its equivalent, or those courses held as Correspondence courses.** These exceptions shall be noted with an asterisk.

The Course Content Number which immediately precedes the course title is used to determine duplication of content between courses. Education credit cannot be awarded when an individual duplicates a pre-license course they have taken previously.

*Cannot be accepted for continuing education credit.

Mandatory Tests: All pre-license programs are required to include at least one test. These courses, whether taken for prelicense or continuing education purposes, must be taken in full - including successful completion of tests.

Law School Courses for Pre-License Credit Only

Law School Courses: Any of the following courses can be used in meeting the educational requirements of the Nebraska Real Estate License Act as long as they are taken from a law school accredited by the American Bar Association and Association of American Law Schools. Contracts I and Contracts II is counted as one 30 hour course. Property I and Property II is counted as one 30 hour course.
